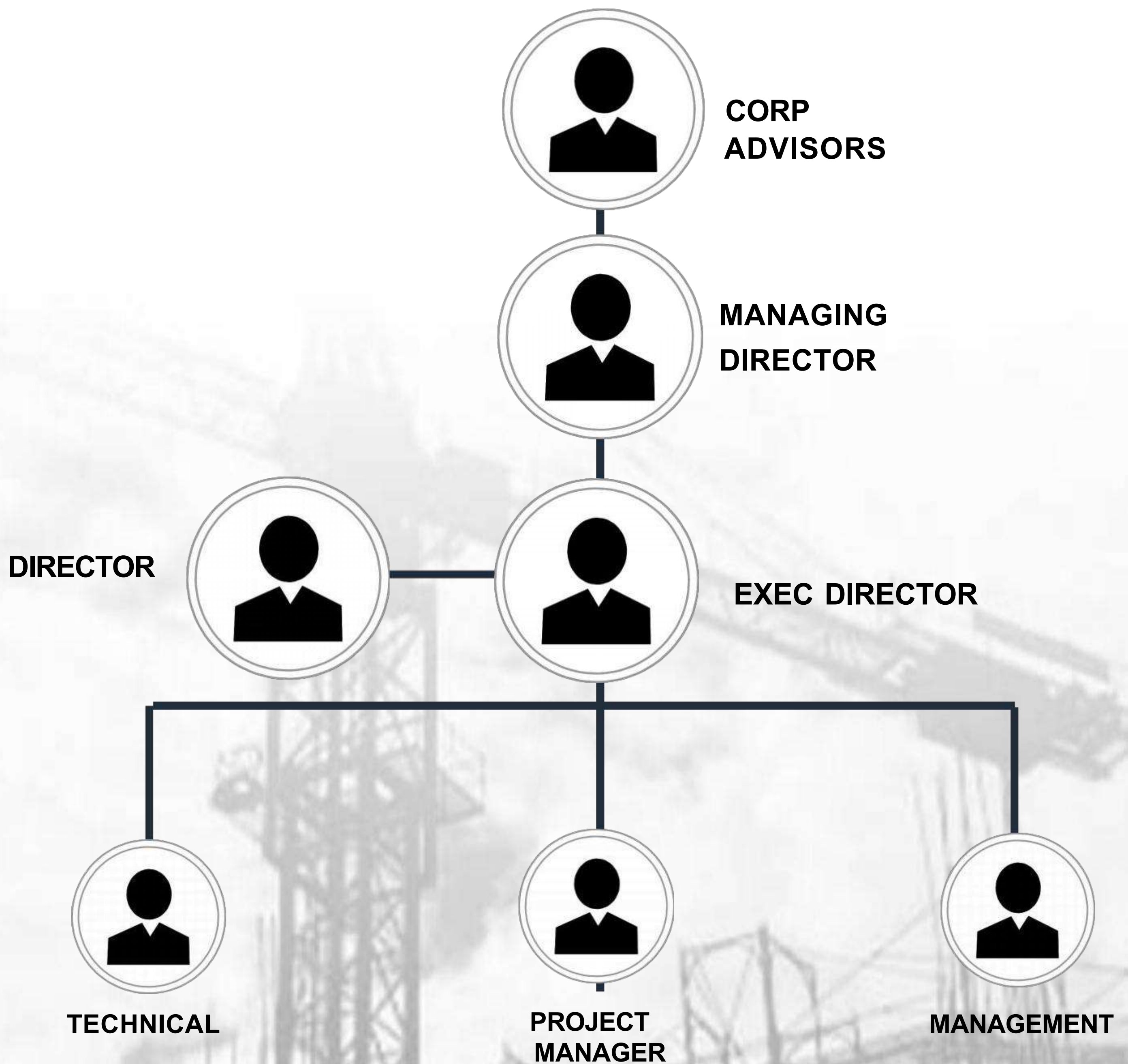

PROFESSIONAL EXPERIENCE:

Datuk Iskandar graduated with BA (Hons) in Art and Social Science. He also pursued to enter in the Malaysia Civil Service (MCS) with a Diploma in Public Administration from the Malaysian Institute of National Administration (INTAN) in 1979. He was first appointed as Assistant Secretary in the Ministry of Foreign Affairs in 1979. In 1981, he was attached for 3 months at the Malaysian Permanent Mission in New York, USA as part of the Ministry's training program for young diplomats. In 1983, Datuk Iskandar was appointed as Second Secretary at the Malaysian Embassy in Jakarta, Indonesia. Jakarta is one of the most important Malaysian diplomatic missions in the ASEAN region especially on bilateral relations between Malaysia and Indonesia.

Having completed his posting in Jakarta, he was then transferred to Lagos, Nigeria as First Secretary and Head of Chancery and Deputy High Commissioner at the Malaysian High Commission in Lagos. Nigeria is the most important country in West Africa and is also the most populated nation in the African continent. The Malaysian High Commission in Lagos is also accredited to Ghana.

Datuk Iskandar completed his posting tenure in Nigeria in 1988 and returned to Malaysia to take up the post of Principal Assistant Secretary in the Organizing Secretariat of CHOGM (Commonwealth Heads of Government Meeting). Malaysia hosted CHOGM in 1988 which is the biggest political event held in Malaysia since her independence. From 1989 to 1990, Datuk Iskandar was the Principal Assistant Secretary for political desk in charge of Sub Continent countries including India, Pakistan, Bangladesh, Sri Lanka, Nepal, Bhutan and Maldives.

In 1990, he was tasked by the Ministry to establish the Malaysian Embassy in Santiago, Chile in South America. He served as Charge de Affairs/Councilor/Head of Chancery and later Deputy Ambassador of the Malaysia Embassy in Chile, and extended to include Colombia, Ecuador and Peru. He served in the mission until 1995.

In 1995, Datuk Iskandar was once again tasked by the Ministry to establish another Malaysian diplomatic mission in the war-torn region in Balkan where he was responsible for the establishment of Malaysian Embassy in Sarajevo, Bosnia and Herzegovina. Malaysia is one of the few countries that participated in the implementation of the Dayton Peace Agreement in both military and civilian programs. He held the position of Deputy Ambassador and Head of Chancery until 1998. Datuk Iskandar returned to the Ministry of Foreign Affairs in 1998 and took up the post of Under Secretary in the ASEAN department from 1998 to 2000, whereby he represented Malaysia in many of the ASEAN meetings both within and outside the region.

At age 45 and in the year 2000, Datuk Iskandar was appointed as the Malaysian High Commissioner to Sri Lanka and Maldives. During his tenure in Sri Lanka, he was also elected as the President of the Colombo Plan Secretariat for the year 2005 presidency. It was a significant posting for Datuk Iskandar as during his posting, the government of Sri Lanka signed the peace accord with LTTE which brought an end to one of the longest civil war in history.

After serving 4 years in Sri Lanka, he was entrusted by the government to head the Malaysian diplomatic mission in the Philippines. He was appointed as the Malaysian Ambassador to the Philippines from 2004 to 2006. One of the most significant political events during his stay in Manila was the signing of the Peace MOU between the Government and MILF and the appointment of Malaysia as the Lead Country in the International Monitoring Team.

After 2 years in Manila, Datuk Iskandar was transferred back to the Ministry in Kuala Lumpur to take up the post of one of the three Deputy Secretary Generals. He was appointed as Deputy Secretary General of Management Affairs. Under his department, he supervised the Human Resource Division, Finance Division, Administration, Consular, ICT, Development, Parliamentary Affairs and Internal Audit. He also supervised the 115 Malaysian Mission abroad. The total annual operating and development expenditure was around RM800 million. He was elected as EXCO of the Malaysian Administrative and Diplomatic Association from 2006 to 2010.

In 2010 and at the age of 55, Datuk Iskandar was appointed as the Malaysian Ambassador to the People Republic of China and Mongolia. He served there for 5 years until his retirement age of 60 in 2015. During his stay in China, he had the opportunity to meet all levels of the Chinese leadership and travelled almost to all parts of China and Mongolia. He supervised the Malaysian Consulate General in Kunming, Shanghai, Guangzhou and Hong Kong. He also established the Malaysian Consulate General in Nanning. He actively participated in the celebration of the 40th Anniversary of Malaysia-China Diplomatic Relations.

In supporting China's setting up of the Asian Infrastructure Investment Bank (AIIB), Malaysia was amongst the 57 prospective founding members of the AIIB.

Datuk Iskandar represented Malaysia in the signing of a key framework agreement for the Asian Infrastructure Investment Bank in 2015, held in Beijing. Datuk Iskandar retired on 7th April 2015, after serving the Government for 37 years.

Datuk Iskandar currently sits as an Independent Non-Executive Director and Member of the Audit Committee in a public listed company – Complete Logistic Services Berhad since 8th April 2015. He is also a member of the Board and member of the Audit Committee of Perbadanan Perwira Harta Malaysia – a wholly owned subsidiary of Lembaga Tabung Angkatan Tentera Malaysia since June 2015. He is also fellow member of the Malaysian Institute of Defense and Security, Ministry of Defense since 2016.

In 2017 Datuk Iskandar was appointed as the Non-Executive Chairman of AEON (Malaysia). Consequently, he sits on Directors' Board of AEON-BIG (Malaysia) in 2018. He is also a member of the Board of Directors of Eversendai Corporation Berhad since 2018. Datuk Iskandar is revered the most in his post as the President of The Persatuan Muafakat One Belt One Road (OBOR) Malaysia an organization that promotes bilateral business development and investments between Malaysia and Peoples' Republic of China. Married to Datin Rahmah Mohd Lajis, and blessed with 2 grown up sons, Datuk Iskandar is a keen golfer. He continues to maintain his networking with Malaysia Civil Service, and member of the Alumni of the Malaysian Civil Service Association. He is also member of the Association of the Melaka Datukship. He was conferred with the Datuk title by the State Government of Melaka and Johan Setia Mahkota by His Majesty –The Yang Di Pertuan Agong. He was also awarded a Datuk title by the President of Philippines in 2006

Brig Gen Dato Pahlawan Mohd Tairobi (Retired) dedicated an impressive 35 years of service to the Malaysian Armed Forces, earning a distinguished career that has made significant contributions to both national and international military operations. His military journey began in 1968 when he joined the Army Cadets at the Malaysian Royal Military College in Sungai Besi, and in 1970, he was commissioned into the Royal Malaysian Engineer Regiment.

In the early years of his career, Brigadier General Mohd Tairobi was selected as one of the few Malaysian officers to undergo rigorous special forces training in both Malaysia and Indonesia, an achievement that marked the beginning of his outstanding military trajectory. Notably, he served as the Chief Military Observer in Bosnia and Herzegovina from 1994 to 1995, where he played a crucial role in formulating and overseeing the signing of the peace agreement that helped end the conflict between the warring factions.

While serving as the Chief of Staff at the 1st Division Army Headquarters in Kuching, Brigadier General Mohd Tairobi further strengthened his influence by serving as the Joint Chairman of the Land Operation Planning Committee between Malaysia and Indonesia, fostering collaboration and enhancing bilateral military cooperation.

In recognition of his exemplary service, Brigadier General Mohd Tairobi was honored with a Master's Degree in Defense Engineering by the Malaysian Defense University in 2016, a testament to his ongoing commitment to professional development and his unwavering dedication to advancing Malaysia's defense capabilities.

PROFESSIONAL EXPERIENCE:

Captain Datuk Yahaya Othman (*Retired*), a "Budak-Boy", spent his early years as a military student at the Royal Military College (RMC), Sungai Besi (1978-79). In 1980 he was sponsored by the Ministry of Defense (MINDEF) to further his study in Sydney, Australia. Six years later he graduated from the University New England (UNE), New South Wales in 1986 majoring in the field of Management Science (Operational Research).

Subsequently, he served the Malaysian Armed Forces upon his return from abroad. He was commissioned into the Royal Malay Regiment (RAMD) in 1987; served various key appointments at the 16th RAMD Battalion and in the early 1990, posted to the MINDEF Infantry Directorate (The 15th Floor) as the SO3 Admin and Personnel at where he was awarded the "Sijil Perkhidmatan Cemerlang" an award for top 5% civil servant of Malaysia (1992-93) and accredited among others as the creator and champion of the digitalized personnel database SMAI (Sistem Maklumat Anggota Infantri).

From 1993-94 Captain Datuk Yahaya represented the country at the United Nation's Operation in Mozambique (ONUMOZ), Africa, at where he served as the Chief Military Personnel Officer of the Northern headquarters based in Nampula. He was retired from His Majesty's Service in September 1995, at the rank of Captain.

Captain Datuk Yahaya has wide experiences in personnel and project management; being a Member of the conspicuous Malaysian Institute of Human Resource Management (MIHRM). To date he has secured and managed variety of projects that includes, manpower resources management and maintenance projects with the Malaysia Airlines Group, Pos Aviation (a DRB-HICOM Group of Companies) and for the Malaysia Airports Holdings Berhad (MAHB) at the KLIA, Sepang. He sponsors events organized by charitable organization such as the Red Crescent Society of Malaysia and World Vision; continues in creating businesses that served for betterment of humankind; proposes green technologies in treatment of water in rural areas especially in the state of Sarawak. Brigadier General Dato' Azhar Hj Ahmad, 61 was born in Masjid Tanah Melaka. He retires from the military service in 2023 whereby he has dutifully served the Armed Forces of Malaysia (ATM) for more than 40 years. During his service he held many illustrious and important posts that honed his communication skills that is his forte and niche. He widely travelled the world, as early as in 1986 he was trained in New Zealand and later attended COLLEGE INTERARMEES DE DEFENSEE of France in 1996 for 18 months.

In 2006 he was seconded to serve His Royal Highness (HRM) Sultan of Pahang as the aide-de-camp and due to exemplary communication skill he was retained in the post as a Kolonel for 11 years until HRM demised in May 2019. Subsequently in 2020 he was appointed as the Commander the 3rd Brigade stationed in Sarawak, promoted to the rank of Brigadier General. His main responsibility there was to enhance Border Security of 2,019.5 km long border between Sarawak and Indonesia which is a monumental task.

Dato Azhar's last challenging but somewhat most rewarding posting is as the Chief of Staff at the National Task Force in mid-2021 overseeing the joint operations between the Armed Forces, Police Forces and APMM (The Malaysian Maritime Enforcement Agency) principally to strengthen border control of both land and national waters. The NTF mission was another success especially on border security operations during the COVID-19 pandemic crisis.
